#### **Athletics & Student Activities**

- \*b. The NJSIAA released guidelines for the Summer Phase 1 start up period, some highlights include the following:
  - Phase 1 July 13<sup>th</sup> 26<sup>th</sup>
  - Students must fill out NJSIAA COVID-19 Questionnaire
  - Students must fill out the NJSIAA COVID-19 Screening Questions Daily
  - Temperature checks will be completed daily
  - All persons must wear masks (students may remove during high intensity workouts)
  - Remain 6 feet apart
  - All workouts take place outside (no locker rooms)
  - Students bring their own water bottles
  - Ten student athletes per pod, must remain in the pod for the day
  - No indoor practice
  - No indoor weight training

#### \*c. Sterling Updates:

- Mr. Claybourn and Mr. Klenk met to review implementation plan on June 22<sup>nd</sup>.
- Mr. Claybourn had a SKYPE meeting with coaches on June 24th.
- The guidelines don't change the fact that summer sessions are open access for all coaches and teams. Therefore, coaches will be responsible to implement guidelines. The Athletic Director will oversee to make sure coaches follow guidelines and student athletes are not being pulled by too many sports.
